- West Northamptonshire Council has launched the Crisis and Resilience Fund (CRF) – a new, three-year programme funded by the UK Government to help residents with financial wellbeing.

The CRF brings together four connected strands of support:

- **Crisis Support** – short-term help for sudden emergencies only
- **Housing Support** – help with essential housing costs
- **Resilience Support** – tools and advice for everyday money worries
- **Community Support** – support available through trusted local places

While Crisis Support is available for a small number of urgent situations, most residents will be better supported through Resilience, Housing or Community services.

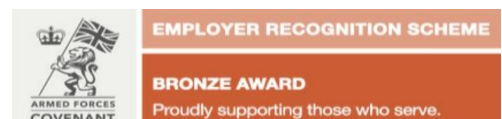
